WAMM Fest is a celebration of Wine, Art, Music and Micro-brewed beer that will take place in Craig Park, Greenwood, Indiana. In its first year, WAMM Fest has received a significant commitment from the City of Greenwood. That commitment allows the Club to offer booth space at a rate that is significantly lower than other community or charitable fairs to which you may have applied. This is a **JURIED SHOW**, at which you can be proud to show your work!!

- \$25.00 Non-refundable Application Fee (separate check from space rental fee)
- \$100.00 Space Rental Fee for individual exhibitor(separate check from Application Fee)
- \$150.00 Space Rental Fee for shared space (separate check from Application Fee)
Shared space to be shared by two exhibitors ONLY!

Please note: Any check returned for **Non-Sufficient Funds** will result in rejection from the show.

Entry Deadline: All entries must be submitted no later than **May 30, 2009**. Visit www.ZAPApplication.org to open your free account and apply online to WAMM Fest.

**ENTRY CONSIDERATION
REQUIREMENTS FOR JURY**

1. Submit ONLY 5 digital photos online at www.ZAPApplication.org. Four digital photos are to be of your work and the fifth is to be of your fully stocked fair booth. (Jewelers 6 + 1). If you are applying for shared space rental (no more than two exhibitors), each person sharing space must submit 4 digital photos online at www.ZAPApplication.org, along with one photo of your fully stocked fair booth.
2. **QUALITY OF ART IS VERY IMPORTANT.** Each photo must be clearly labeled with the artist's name and media.
3. Digital photos must be of work executed within the last 3 years. The work ultimately exhibited during the fair **MUST** be representative of that which is juried. **NO ADDITIONS OR SURPRISES.** Prints must be signed and numbered and limited to an edition of no more than 1000 per image. Any reproductions must be identified as such with the word **REPRODUCTION** prominent.
4. Work must be that of the artist submitting the application. The artist must be present at the fair. **No imports, commercially manufactured items, kits or strung beads will be allowed in the show, and, if found and confirmed will subject exhibitors to immediate refusal.**

SPACE RENTAL REQUIREMENTS

Each exhibitor must provide his/her own display. All exhibitor space is assigned at the discretion of the WAMM Fest Committee. Exhibitor space is 10' x 15'. All exhibitor space is on grass/ground surface. Sertoma Club and City of Greenwood do not warrant surface to be level. All spaces will be filled in order of acceptance into the fair. Set up on Friday,

August 21, 2009, from 4:00 PM - 8:00 PM, or Saturday from 6:30 AM - 8:30 AM. Displays may be left in place overnight at the artist's discretion and at their risk – neither the City of Greenwood nor the Sertoma Club of Greenwood will be responsible for theft or damage to artist's wares, products, displays or other property. Security will be on duty from Friday afternoon at 4:00 PM until 8:00 PM on Saturday, August 22, 2009. **Exhibitors shall not make or create works of art on the grounds on the day of the festival that utilize methods that present an unreasonable risk of injury.** For example, there shall be no activity that involves the artist's use of power equipment, including, without limitation, glass blowing equipment, lathes, power or chain saws, or other equipment powered by means other than human power; nor shall there be use of any tools that imply the chipping or cutting of rock or wood. Any art creation or making on the grounds of the festival shall be subject to control or termination by The Sertoma Club of Greenwood at its sole discretion.

AGREEMENT AND UNDERSTANDING:

I have read, understand and agree to all of the rules, entry considerations and space rental requirements contained on this application. I know that my Application Fee is non-refundable, and that, upon mailing of Notice of Acceptance, the check enclosed herewith for Space Rental is non-refundable and ensures my entrance to WAMM Fest as an exhibitor.

I agree that I shall indemnify and hold The City of Greenwood, the City of Greenwood Parks Department and the Sertoma Club of Greenwood, respectively, their agents, employees, members, political subdivisions, departments or agencies, and assigns (herein "Releasees") free and clear of and from any and all loss, cost, claim, expense, damage, or other liability, including attorneys fees (referred to collectively and individually as "the Liabilities"), that may be asserted against the Releasees individually, jointly, or in any other manner, arising from or in relation to my occupation of booth space at WAMM Fest, setting up and removing any and all displays, tents and other items that may belong to me or be in my possession on or about Craig Park, or its entrances or exits on the day before and the day of WAMM Fest, and which relates to, or arises from actual or alleged actions or inactions, brought against the Releasees by any person, firm, or other legal entity of any nature. The obligation assumed hereby extends to claims for negligent acts or inactions that may be alleged against the Releasees, and also includes the obligation to hold the Releasees harmless from and indemnify them with respect to all costs, including reasonable attorney fees and expenses, they or any of them may incur in defending against or responding to, the Liabilities. I understand and agree that the Releasees intend that they should have no liability, incur any cost or assume any obligation as a result of claims made against them by any person or party resulting from or in respect to WAMM Fest. I therefore from this day forward, release the Releasees of and from any duty or obligation, if any, whether by virtue of contract, common law, negligence, or otherwise, they may have to me, my heirs, employees, contractors, or assigns, that may arise after the execution hereof that occurs at or results from or in relation to WAMM Fest. I further agree, with respect to the Sertoma Club of Greenwood, that, if I or my agents, employees, assigns or heirs bring any claim against it, its members, board, volunteers, or agents for breach of this agreement, my sole and exclusive remedy will be to seek return of my space rental charge.

I understand that if I am signing this Application with another person, that the above agreement binds each of us, individually, jointly and severally, to the terms hereof.
